

STRATEGIC PLAN 2005 - 2010

Tresillian Family Care Centres

The 2005-2010 Tresillian Family Care Centres Strategic Plan, builds on the significant outcomes and directions of the previous Strategic Plan.

Through wide consultation with key stakeholders, this Plan proposes strategies to guide service and corporate development within Tresillian until 2010.

The development phase of the Plan included extensive review and analysis incorporating a strategic review of literature on child and family services and relevant policy

and planning documents at a State and Area Health Service level. This Strategic Plan has been designed to meet the ever changing needs of the families who utilise Tresillian's services.

This Strategic Plan demonstrates the commitment that Tresillian Family Care Centres has towards continuing to build partnerships with child & family networks in Area Health Services, NSW Health and both government and non-government organisations and continues to provide education and care for families with young children.

OBJECTIVES

The Strategic Plan forms the basis for the development of our future planning at Tresillian.

OBJECTIVE 1

Review, re-define and re-balance its mix of services, so that maximum advantage is taken of its specialised, leadership role and the opportunities that exist for additional funding.

OBJECTIVE 2

Consolidate and enhance its leadership role in Child and Family Health.

OBJECTIVE 3

Consult with relevant parties to identify strategies that improve access to services by disadvantaged population groups.

OBJECTIVE 4

Formalise and strengthen its partnerships with government and non government organisations with whom it works.

OBJECTIVE 5

Expand the quality improvement activities and maintain an effective OH&S risk management program. This will include consumer participation in future planning and enhance the range of evaluation and monitoring activities.

OBJECTIVE 6

Use the opportunity afforded by the Willoughby re-development to improve the functionality of some services.

OBJECTIVE 7

Alert the relevant nursing and workforce taskforces about the current and projected shortage of child and family health nurses and lobby for strategies that may improve or reverse the situation.

OBJECTIVE 8

Create an environment where communication is open and decision making is clear and transparent.

Council Members, management and staff, will work collaboratively on the implementation of the objectives contained in the Strategic Plan, which have all been endorsed by the Tresillian Council. The General Manager reports to the Council on the progress made in relation to the achievement of each objective.
